			ADS R115 - Alcohol, Drugs, Eating Disorders and Nutrition— Non-substantial revision Changes needed: Change catalog start date to Fall 2019. Typical graded assignments: Need to see more evidence of rigor since this is a baccalaureate level course. Essays must be included and we would expect to see a few shorter papers or one longer research paper due. Methods of Instruction #4 - perhaps not a method of instruction, consider adding "instructor critiques of Textbooks/Resources: Journals are mentioned in the

assignments so it might make sense to list a journal or two here.

ADS R124 - Ethics and Confidentiality for Alcohol/Drug Studies— Non-substantial revision
Basic Course Info: Catalog Start Date should be Fall 2019

Units/hours: should be a range of hours from 48 to 54. SLO #2 - Please revise language to make more assessable.

Methods #4 - may not be a method of instruction In DE Appendix change CMS to LMS. Course content contains 11 topics and is quite thorough. Course objectives should probably reflect more closely the content.

R. Williams introduced the revisions to the AT courses.

AT R014 - Advanced Engine Performance – Nonsubstantial revision

Basic Course Information: missing SAM code SLOs: #4 seems more like a graded activity, #3 and #7 are identical and not clearly measurable as written ("improve in their ability...")

Non sub - Course Content: select "DONE" so box is checked

Typical Graded Assignments: #3 is indicated as a laboratory assignment but there are no lab hours for this course, remove and put in AT R014L if needed Other Instructional Materials: Check for newer editions? CA automotive repair laws 2002 edition is shown.

Non sub - Attached Files is checked: remove file with attached SLOs now that SLOs have their own page. Methods of Instruction: Move the applicable Methods to current area from the Legacy methods area one at a time and remove the Legacy methods.

AT R014L - Advanced Engine Performance Lab - Non-substantial revision

Basic Course Information: Missing TOP code and SAM code

SLOs: #4 difficult to measure "students will improve ability to remember..."

Other Instructional Materials: check for more recent?

CA automotive repair laws 2014 instead of 2002?

AT R016 - Auto Electronics - Non-substantial revision

SLOs: #4 is difficult to measure "improve in ability", #5 seems more like an assignment, maybe change to "Students will accurately complete wiring diagrams" DE Appendix: if this course isn't going to be offered online, it should be blank and page unchecked.

#### AT R018 - Automotive Brake Systems

Non-substantial revision

Basic Course Information: TOP code, CB04, CB21, and CB24 all missing

SLOs: #3 seems like a method of instruction, #7 is difficult to measure "improvement", some seem like Methods of Instruction. Drop use of 'comprehend and replace with 'prove ability to successfully perform...'?

AT R018L - Automotive Brake Systems Lab

Non-substantial revision

Basic Course Information: TOP code missing Unit / Hours: change to Yes for variable units to allow for range of hours. Upper limit of contact hour range should be (72)

SLOs: #1 difficult to measure "improve" unless doing pre and post-test in class, #4 and #6 are same Lab Content: Outline formatting needed, Make into numbered/lettered list with headings/subheadings just a reminder lab content should be clearly "lab" unlike course content which should be clearly "lecture" as this is a lecture / lab combination course

DE Appendix: This is a lab course and this page should be blank. Remove information about instructor provided content if possible

AT R020 - ASE Mechanics Certification

Non-substantial revision

Basic Course Information: TOP and SAM codes missing, Title V repeatable?

Course Objectives: #3 seems more like a method of instruction, maybe take out the "Dialog with Instructor"

and change to "Become familiar with..."?

SLOs: might want to put in a few placeholders such as, "Correctly identify components of heating system" just to have something there since if this is a 5 year review and the course has not been run in all that time (since SLOs will be determined next time the course is run) why is it still offered?

Non-sub Methods of Instruction: random "1" at the top, leftover formatting?

Methods of Instruction: maybe remove #2 about taking tests since it seems like a graded assignment and is mentioned there

S. Davis: With the exception of courses covered under Title 5 55041, a course is not repeatable unless there's something legally saying that they must repeat it.

AT R026 - Automotive Engine Overhaul

Non-substantial revision

Basic Methods of Instruction: TOP code missing SLOs: #3 difficult to measure "improvement" unless doing assessment at start and end of course maybe just remove word "improve" so say, "Students will be able to identify, retrieve, etc."

Non-sub? Method of Instruction: random "1" at the top, holdover from previous formatting (seen in several others as well)

Typical Graded Assignments: Remove "Instructor feedback" from #4, so just has students role-play assignments

Outside Assignments: formatting seems off, historical maybe?

Methods of Instruction: Move methods from Legacy Methods to the current area if you want to keep them. The Legacy Methods are to show you what the course did have but want you to choose the ones that are still applicable by entering them one by one above.

AT R026L - Automotive Engine Overhaul Lab – Non-substantial revision

Why does a lab class have any lecture at all? Shouldn't the lecture class cover all the lecture and the lab portion just be lab hours? Is this a CTE lab thing? Basic Course Information: missing TOP code, Missing SAM code.

Course Content / Lab Content are identical but this

course is a lecture and lab combined so should be differences between the two with lecture content clearly lecture (methods of testing) and lab content clearly lab (doing of test)

Methods of Instruction: random "1" at the top, formatting thing?

Outside Assignments: formatting seems off Methods of Instruction: move legacy methods that apply to the new area, remove legacy.

Non-sub edits: Minor formatting issue in Lab content with bullets instead of letters/numbers. SLOs: use of 'comprehend' in the SLOs?

AT R030 - Automotive Transmission and Drive Line – Non-substantial revision

Basic Course Information: missing TOP code, CB24 SLOs: #3 difficult to measure "improvement" unless have before and after test, #5, #6 might want to change "know how" to "demonstrate", #8 seems like a method of instruction or a graded assignment Method of Instruction: random "1" at top of the list,

Typical Graded Assignments: nothing clearly "essay" included but essays are marked as a Method of Evaluation.

Outside Assignments: formatting seems off? Attached Files: remove SLO file

Methods of Instruction: add current methods, remove

legacy methods.

formatting?

AT R030L - Automotive Transmission and Drive Line Lab

Non-substantial revision

SLOs: #1 "students SHOULD know" seems a little wishy-washy, not measurable. Replace terms like 'should know' with 'will be able to demonstrate'?? Methods of Instruction: Random "1" at top of list? Formatting?

Outside Assignments: formatting seems off? Textbook: anything newer than 2012?

A.Lynch introduced the CNIT courses.

CNIT R151 - Cloud Computing and Virtualization – Non-substantial revision

Objectives: Last objective wasn't obvious in course content. Where are they learning how to "formulate high level cloud migration strategy and best practices?" Units/Hours need to be set to variable.

Textbooks: Textbook is 5 years old, in the computing world does that mean it is ancient by now? Consider finding a more recent text.

Typical graded assignments: are end of chapter exams and end of chapter quizzes different things? Is "Cloud" a proper noun requiring capitalization?

A. Lynch: Decided to change pre-req to advisory. Will improve enrollment and allow more people to take the course.

CNIT – R161 (R160) Programming Essentials in Python

Basic Course Information: I know it probably can't be changed but there is a IT C-ID 160 which is for security so having our intro to programming course be 160 is a little confusing

Unit / Hours: change variable units to "Yes" so you can make a range of hours and change the upper limit of contact hours to 72

Course Objectives: I am not certain I would recognize all the C-ID objectives in this course. Maybe use some of the same language where you can, so for #7 say, "Apply core program control structures using Python."?

- 1. use primitive data types and data structures offered by the development environment.
- 2. choose an appropriate data structure for modeling a simple problem.
- 3. identify basic programming concepts.
- 4. write simple applications that relate to a specific domain.
- 5. design, implement, test, and debug a program that uses each of the following fundamental programming constructs: basic computation, simple I/O, standard conditional and iterative structures, and the definition of functions.
- 6. test applications with sample data.
- 7. apply core program control structures.

Course Content: I am having trouble matching the C-ID

content to the content in this class. I am sure it is there but I don't recognize it and I'm not certain the reviewer will be fluent in programming to be able to find it as well.

Methods of Instruction: #2 is kind of long, maybe include only one or two examples instead of all of them?

Outside Assignments: formatting for reading and other seems off

DE Appendix: change LMS to CMS and remove references to specific technologies (CCC Confer) as they may become outdated

Non-sub: units/hours need to be variable. MOI formatting?

Objectives and content are thorough and well-written.

A. Lynch - recommendation by the advisory council. Programing courses not offered since 2010.

CNIT R180 - Certification Preparation — New Course Requisites: Did you want to add the new course, CNIT R160 to the list of possible prerequisites? SLO's: in appendix additionally?

Units/Hours: choose yes to variable to allow for range of hours.

Content review:, Check off the box next to the courses and then choose the objectives that apply.

CNIT R198 - Short Courses in Computer Networking/IT Comments in CurricUNET: Should a DE Appendix be included in the event the course would be taught online? Or does that need to be added on a case by case basis? S. Davis: No, when specific courses are created under this umbrella they must be brought through the Curriculum Committee and those courses would have a DE Appendix if appropriate.

- S. Davis: Suggested the curriculum committee stop requiring faculty to bring through 98/99189/198 classes (all the umbrellas) for 5 year review since they only contain boilerplate language. In addition, the Directed Study courses, all R199 would only be brought through if there were changes.
- S. Hall requested this item be added as an agenda

P. Mendez introduced the revisions to the ECE courses. At this time, they are all 5 year reviews with changes made to

ECE R100 - Introduction to Curriculum for the Young Child - Non-substantial revision.

Course Catalog Description: Description is made of 2 very long sentences that could be divided into 3, maybe 4, sentences for more clarity. The use of semicolons in the second sentence should be replaces by commas. The word course should be added after "This" = This course addresses ...

Range in Contact Hours is missing. Check yes for variable units to allow the range to save.

Course Content: The only content item from the C-ID descriptor that is not in the content on this COR is "The Role of the ECE teacher", which should be added since it's in the objectives as well.

Basic Course Info: Not transferable is marked, but this is a 100 level course and should be transferable. Methods Instruction: some aren't methods of instruction Objectives: #1 "Recognize developmentally appropriate principles and teaching strategies..."

 teaching strategies may not be evident in course content

ECE R103 - Programs for Young Children

Non-substantial revision

Units/Hours: Range for contact hours is missing. Under Methods of Instruction: #6,7,8 sound more like methods of evaluation.

Typical Graded assignments: do not include an essay. Course Content: To better align with current C-ID descriptor, add "delivery systems" (would work as a subheading after The types of programs), "Quality Indicators" (such as accreditation), "Licensing and Regulation", and "career options."

Methods Instruction: Some aren't methods instruction

ECE R106 - Child, Family and Community – Non-substantial revision

Course Content: C-ID descriptor has "Effects of Stereotypes, biases, and assumptions" but this isn't in the COR so should be added. Look again at descriptor and make sure all topics are covered and easy to find

on COR. Descriptors are reviewed and revised every 5 years and may add content that wasn't there previously when we first aligned our course.

Units and Hours: Need to add range of hours. Textbooks: Text is almost 5 years old already. Add another newer text to the list.

Some methods of Instruction sound like methods of evaluation (#3,4,6,8)

ECE R133 - Language Arts in Early Childhood – Non-substantial revision

Course Content: Last subheadings are written in the form of questions and should instead be written in the form of topics. For example: "What is the definition of an English Learner" should instead be "Definition of an English Learner"

Make sure that the objectives are reflected in the content. The last objective is "Develop cultural literacy..." and I don't see where this is being taught within the content.

Catalog start date should be Fall 2019
Contact hours needs range
SLO #1 could be two separate SLOs
Methods of Instruction: 2 and 3 are not methods
Graded assignments - no essay listed but essays are required for this type of course per Title 5.

DH R015 - Introduction to PreClinic/Clinic for Dental Hygiene— Non-substantial revision
Minimum Qualifications: MQ License? Course Content - consider revising format so that there are fewer categories with sub groups for clarity. For example, items II and III should probably be sub-categories of item I. Course Content and lab content are the same. Methods of Instruction: #2 may not be a method of instruction - consider revising.

SLOS: Revise #2 and #3 - perhaps, "Demonstrate correct technique in the use of..."

Section E. Fees is blank but this course requires a fee so add the amount.

A. Derdiarian: 5 year review completed last year and materials fee was \$0. Reinstitute materials fee. Student issue is \$8,000 - \$10,000. As a materials fee, student can now qualify for financial aid.

All course and content lab are identical because it's all lab.

DH R024 - Dental Hygiene Clinic Seminar I – Non-substantial revision Section E. Fees -- none listed, add new fee.

FT R155 - Fire Protection Equipment and Systems - Non-substantial revision.

DE- no need to list methods if it is not going to be taught DE. Leave DE Appendix blank.

Proficiency Award in USLA Lifeguard Academy I - New program. Requires DTRW-I and BOT approval.

Edits: Catalog Description--Misspelled words: lifeguard, rigorous, academy, communications, lifesaving, rescue, lifesaving, athletically Course blocks section blank?

For introduction to the award: Let's add an introductory sentence like "This proficiency award recognizes the completion of the Oxnard College Lifeguard Academy I."

Typo in Title with capital I in "Lifeguard."

#### **Liberal Studies**

R. Mack introduced the changes to ART R101 and the new ART R174.

ART R101 – Introduction to Art and Visual Culture – Non-substantial revision.

Objectives: Not sure that all of the C-ID objectives are covered in outline such as descriptor objective #3. "Differentiate art historical methodologies." Make sure the reviewers can find each one easily.

Essays are required (per Title 5) so writing assignments should be included in outside assignments.

for.

SLO's: need to complete SLO page and add all SLOs. Field trips need to be repeated in outside assignments? Methods of Instruction: #3, 4, 7 - These may not strictly be methods of instruction, consider adding the usual boilerplate, something like "instructor-guided."

Remove: "Field trips may be required." from course description, repetitive.

- R. Mack Primarily focused on description that will go into course catalog. Title incorporating something closer to the CID title Understanding Art. Proposed: Introduction to Art and Visual Culture.
- S. Newby: Does it have to match the CID title no per S. Davis

Some suggested "Appreciation" is out of date.

L. Kama'ila: Since art is a very visual culture – fear would be that someone at the state level would question if there's enough room to get enough art in there as a sub-category of visual culture. Is there a lower division course that is intro to visual art at any other college?

## ART R174 - Latin American Art- New course. Requires DTRW-I and BOT approval.

Course Content: Might want to make the content a bit more general, rather than listing specific cultural regions or nations. What if an instructor wanted to include different areas or groups? Topic C, change "Columbia" to "Colombia"

Course objectives: #1 states "Identify, examine, and assess ...employing appropriate art historical terminology, "art historical terminology" is not included in course content.

Course content: Textbooks: 1 & 2 out of date

R. Mack - New course intended to compete a sequence, initiated a couple of years ago – Art of the Ancient Americas. Idea is to bring that story to present day. Categorized as non-western.

# ENGL R097S - Writing Support for Intermediate Composition— New course. Requires DTRW-I and BOT approval.

Catalog Description should not mention ENGL R100 since there is a co-req course being developed for that course.

Requisites: Remove ENGL 100

Methods Instruction- some are not methods instruction

Typical Graded Assignments- No essays listed but they should be required in this course.

Requisites "This is curriculum is designed to enhance ENGL R097 or ENGL R100"

 delete first "is" to read "This curriculum is designed..."

# ENGL R101S - College Composition Co-requisite Support – New course. Requires DTRW-I and BOT approval.

Basic Course Info:Is the C-ID in progress? Or should this be unchecked?

Methods Instruction- Some are not methods of instruction

Course Description: "This corequisite support course provides additional help and support for students enrolled in ENGL R101 College Composition."

 the word support is used twice in sentence; consider revision.

Reason course offered: "This is new corequisite course..."

• "a" missing to read "This is a new corequisite course" (?)

#### SPAN R119 - Cultures of Latin America

#### - New course. Requires DTRW-I and BOT approval.

Comments: Hours 48-54

Objectives: re-word "Develop an awareness" since awareness is difficult to assess.

Need to list MQs -- Master's in Foreign Languages (Spanish)

Requisites: On advisories, change and/or to "or"
Either need to add a prerequisite instead of an advisory requiring a certain level of Spanish proficiency or change SLOs to not require that students read and write in Spanish. An advisory is merely a recommendation and cannot be enforced and students with no Spanish could enroll but with those SLOs could never be successful

Basic Course Info: Missing TOP Code and Course Credit Status

Content Review – Edit the page and check the box next to the advisory and then select the appropriate objectives.

Does Typical Graded Assignments need a list format?

M. Hurtado: Developed course to be one of the courses

that is optional to complete AA-T in Spanish. Additional courses needed for students who come in and place higher but need additional courses

S. Newby suggested sentence be added to the course description stating this class will be taught in Spanish.

A. Sandford & J. McArthur made suggestion to add "the class is conducted in Spanish" to course description.

M. Hurtado: Under minimum qualifications, Spanish is not offered under drop down which is why foreign languages was chosen.

BIOL R100/MST R100 - Marine Biology - Non-substantial revision.

Methods of Instruction, Typical Graded Assignments, Outside Assignments:

 Look for repeated use of "such as" and add consistent punctuation; for example, use semicolon before and comma after or comma before and after depending on what follows.

Units/Hours: Check Yes for Variable units to add range of contact hours.

BIOL R100L/MST R100L - Marine Biology Laboratory 2 of 4 textbooks out of date.

CHEM R122 - General Chemistry II

Non-substantial revision.

Units / Hours: Change variable units to "YES" so you can add the upper limit of contact hours (162) Content Review: Select CHEM R120 then select all the CHEM R120 course objectives you feel students should have before taking CHEM R122. Since it is sequential, would select all of them Course Content: The C-ID suggests Coordination Chemistry and Descriptive Chemistry for the second semester. They are probably already included in the course content but it's not really obvious so you may want to spell it out where those topics fall Methods of Instruction: This is the legacy formatting. You need to cut and paste each method and add them separately. Then make certain you click "FINISH" Typical Graded Assignments: Don't think you have to include HOW you are going to grade the assignments (the first two paragraphs) as long as you have samples of the types of assignments you will offer. Since you have ESSAYS as a Method of Evaluation you should make certain one of the assignments is obviously an essay.

Reason Course is Offered: "for students majoring (instead of major) in..."

Unit / Hours: set to variable so can put in upper limit of 54 at the bottom for total contact hours
Course Content: Formatting looks off
Methods of Instruction: Method 1 is bit vague, might combine it with #5 and say, "Lecture and instructor-led discussion on engineering topics, including historic feats of engineering (building the Brooklyn Bridge)
Typical Graded Assignments I. use of "such as" should

include semicolon before and comma after.

# **ENGR R150 - Engineering Graphics and Design— New course. Requires DTRW-I and BOT approval.**

Basic Course Information: Change C-ID Status from Approved to In Progress. Remove UC from CB05 Course Transfer Status. The Articulation Officer will add these once we have approval.

Minimum Qualifications; No minimum qualifications to teach the course? Select the appropriate MQ from the dropdown menu. Should instructor have CAD certification?

Methods of Instruction: Since Lab consists of utilization of CAD software, this should probably be mentioned in the Methods as well as you will be demonstrating its use.

Units / Hours: change variable units to YES so you can add the upper limit of contact hours (54), Weekly LECTURE hours should be 0 and weekly LAB hours should be 3

Course Content: Has the list from the LECTURE but needs to be the LAB content and be fleshed out a bit. Then cut and paste into the lab content page

- 1. Test and Measurement equipment: Use of each item for specific purposes
- 2. Circuit construction techniques for laboratory use ("breadboarding")
- 3. Component identification and labeling; nominal and measured values; limitations on voltage, current, power dissipation

Typical Graded Assignments: Need to have assignments or activities that demonstrate the student

Students will explore tools, techniques, and skills to help them perform their role and manage their emotions with confidence and positive results.

CB03, CB04, CB09, credit basis are all missing.

Some Course Objectives are not measurable (D - Understand) Formatting needs attention.

SLOs - Take out "Will" at the beginning of each SLO. Start with Recognize ... and Analyze and interpret ... Methods of Instruction: Not clear what is meant by "multiple measures".

Typical Graded Assignments are still needed for noncredit. There needs to be a method for assessing students.
