		 S.Davis explained the different reasons for this project. Every course will need to come through the Curriculum process, unless you just did it this fall. Most of the Courses will stay the same, but there are blank fields in the form because they are new. Faculty should do any updates that you would normally do during a 5-year review. If the course is good as is, just complete the new required fields. Courses with no additional changes will come to first and second reading here and then will be done. But if you do make any substantial changes, they will need to go through DTRW – I and board. S. Davis added that we are looking at how to break up the workload and organize the disciplines, if you know you have a busy fall ahead of you we will be taking volunteers who want to get started on it this Spring. M. Pinto-Casillas asked if there is a Deadline for faculty who choose to submit in fall. S. Davis replied not at this time, those details are still being worked out. A.
