Faculty of courses under such review will be able to make a case for their course remaining within the current GE area by appealing to the General Education Committee in writing prior to the vote of the Curriculum Committee. After a thorough review of the course outline including SLOs, and review of the

			circumstances and policy or documents as appropriate, the course shall only be removed by vote of the GE Committee and subsequent vote of approval by the Curriculum Committee. If an appeal has been made and the GE Committee still votes in favor of the removal of the course from the GE area, the Curriculum Committee will still hear the faculty's argument in favor of retaining placement within the GE area prior to its vote. The Curriculum Committee's decision will be considered final."
