- I. Review of April Meeting Notes no changes suggested.
- II. General Education SLOs PRIORITY FOR THIS ACADEMIC YEAR

Accreditation Standard II.A.3. "The institution, relying on the expertise of its faculty, determines the appropriateness of each course for inclusion in the general education curriculum by examining the stated learning outcomes for the course."

A. Shannon went over the Brief Recent SLO History: (appeared on agenda too)

- 1. LOT identifies GE as a program and therefore in need of SLOs. This is supported by the Accreditation requirement above. This is presented to the GE Subcommittee at the 3/18/09 meeting. A plan is made to collect SLOs from all the courses in the GE areas and work backwards.
- 2. At the 10/14/09 meeting, the GE Subcommittee reviews GE SLOs from other CCCs and CSUs, chooses American River College as a model, and adopts a new plan for creating SLOs which involves GE Subcommittee reps taking the model and sample SLOs back to their departments to work on SLOs for their respective GE areas. SLOs are then to come back to GE Subcommittee for review/editing by 11/11/09 meeting.
- 3. 11/11/09 meeting was cancelled.
- 4. At the 2/24/10 meeting, all other GE business was put on hold in favor of prioritizing SLOs, including the review of new courses to be added to GE and the review of courses currently included in each GE area. Discussed approval process of SLOs GE to recommend draft to Curriculum to approve and then sent to Senate. GE reps to continue to pursue creation of SLOs in their GE categories. Chair to send samples via email to those involved in areas still needing SLOs along with reminders.
- 5. At the 4/14 meeting, submitted SLOs for Language & Rationality were reviewed, edited, and then the committee decided that they should be sent to Math, Philosophy and Speech for their input/approval before being finalized. The Natural Sciences SLOs were handed out and briefly looked over, with the committee being concerned that there were so many SLOs. PE/Health Reps. Attended this meeting to get clarification of what was needed for their area.

6. Prior to this meeting, an email was sent to the new Social Sciences Chair with a description of our process, sample SLOs and the request for their department to put this on their meeting agenda for today, 9/20/10.

B. Shannon went over the GE Area SLOs and where they stand today Language and Rationality (rep: Jenny Redding)

- Submitted by Jenny on behalf of Letters dept. on 10/20/09
- Sent to Math, Philosophy & Speech for review/input on 4/14/10 per committee request. Bret Black (Math) emailed that they looked fine to him but had questions on how they would be assessed. Hussein asked Marlene and Lilia for help and they sent emails that they were confused by what we were doing and if these replaced the institutional SLOs so I reminded them that we were charged by LOT to create these SLOs and explained our process. Email received from Jim in Letters wanting to make sure that everyone understood that courses qualifying for D-2 would not be expected to meet all of the SLOs. He also wanted the other depts. Represented in D-2 to know that Letters didn't create these SLOs, but chose them from sample SLOs provided and was not trying to force the other depts. to adopt them, this was just their input on the area; the SLOs they felt most useful.

It includes the charge, a membership list, Meeting agendas and notes, and reference documents. In the future, agenda, notes, and hand-outs will be posted to the site as well as the GE SLOs.

D. Review of Natural Sciences SLOs

The committee went over the SLOs, eliminated those that were repetitive, too specific to one course or found to be unlikely to be measured in course level SLOs and combined others to come up with a new reduced list of only 4 SLOs for Natural Sciences.

ACTION ITEMS:

Chris Mainzer will type up the new SLOs and present them to her department at their 9/23 meeting this week for input and approval, then bring it back to the committee.

E. Review of PE/Health/Athletics SLOs

The committee felt that although the SLOs presented were good, they were missing a few things including more of the social and emotional aspects of personal development that occurs in sports or health courses that isn't just physiological. The group felt that maybe one SLO added to each area would make it more complete.

Shannon will email Carolyn, Jonas and Graciela with the committee's suggestions and some more sample SLOs that address the missing topics.

- **F.** Review of Communication and Analytic Thinking SLOs for area D-2 The committee felt that ample time had been given to Math, Speech, and Philosophy to respond and since there was no objection, these SLOs stand.
