## CALIFORNIA VETERAN EXEMPTION – VACA/AB 13

**For Eligible Veterans and Dependents who reside in California. Documentation is required to establish eligibility.**

Covered individuals must enroll at Moorpark, Oxnard and Ventura Colleges (VCCCD) within 3 years of the discharge date (or the discharge date of the member in the cases of dependents) in order to qualify for this exemption. The covered individual must also be physically present in CA and must have served at least 90 days in active duty status (or in the case of dependents, the member must have served at least 90 days in active duty status). Students using the Marine Gunnery Sergeant John David Fry Scholarship, eligible dependents of active duty service members, and training and rehabilitation for veterans with service-connected disabilities are not required to enroll in one of the colleges of the VCCCD within three years to qualify for the exemption.

The student must qualify for "covered individual" status as of the "residence determination date" applicable to the term in question as provided by California Code of Regulations, Title 5 Section 54002). If a student veteran is not VACA eligible at the start of a term and becomes VACA eligible during that term, the student does not qualify as a "covered individual" for that term. However, the student is eligible for "covered individual" status under the VACA Act for the subsequent term.
