Oxnard College is committed to its student veterans' success and the Veteran Resource Center. If grant funds are not allocated to the college we will continue to support these services with Student Equity, SSSP, general funds, and grants.

Oxnard College understands the overwhelming challenges veterans are likely to face in their transition from military to civilian life. To help support veterans in their pursuits, the College established and opened the Veterans Resource Center in spring 2010. From its inception, the College has reached out to our military veteran community. Our service area in Ventura County consists of over 54,000 veterans and their dependents and includes two naval bases and one air National Guard base.

The College's focus has been to assist our student veterans along their chosen paths with the assistance they need. Oxnard College facilitates veterans' transition from combat to campus by serving their unique needs through a comprehensive one-stop-shop. We provide the academic, psychological, vocational, and financial aid support necessary to improve their overall success in obtaining college degrees or certificates and subsequent transfer to the university. Services include counseling, substance abuse support, educational pathway guidance, assistance with navigating veteran benefits, financial aid programs, workshops, and tutoring.

Oxnard College's goal is for every veteran to have a seamless pathway to pursuing future opportunities with career-ready knowledge and skills for success.
