ESTEEM Project: OCF has a 5 year Subaward Agreement with UCSB in the amount of \$375,000. We have received a total allocation of \$225,000 for the first 3 years for the period ending 6/30/2020. In this period, 7 additional OC ESTEEM Scholarships in the amount of \$2,500 each, were approved after the deadline by Marcella Klein Williams and she is asking the OCF to cover the unfunded amount of \$12,300 until the next UCSB allocation goes through prior to written authorization from Cristina Wilson, Financial Manager, UCSB Chemical Engineering at UCSB.
