**Revision to District Governance Handbook:** A draft revision to the core content of the District's *Participatory Governance Handbook* has been posted to the portal for your review and can be found at the following link: http://domapps.vcccd.edu/Announce.nsf/0/46A46848E4C3BFDC882579DB0059F08A/%24File/Participatory%20Governa

<u>ce%20Handbook%20rev%2004%2006%20clean.pdf?OpenElement</u> As drafted by the Chancellor's Consultation Council, the *Handbook* describes the role each employee group plays within the governance structure and outlines the functions of the various district administrative, advisory, and governance bodies. New to this revision is a description of the District Council on Accreditation and Planning (DCAP) [found on page 16] and the District Council on Academic Affairs (DCAA) [found on page 18]. As drafted in this document, DCAA would be supported in its work by the District Technical Review Workgroup – Instructional (DTRW-I) [found on page 19] and the District Technical Review Workgroup – Student Services [DTRW-SS] (found on page 22). For those who would like to see the relationship of the proposed document to the original *Participatory Governance Handbook*, a version with all of the changes tracked has also been posted to the portal. Finally, a document on the portal labeled *Governance Process Chart* can be found at the following link:

This document shows the relationship of the various Councils to each other, identifies the pathways by which recommendations make their way to the Board of Trustees, and charts the feedback loops that will now be built into the system. Faculty, staff and students should provide their feedback regarding these documents through their respective Senate Presidents.

Ventura College Colleagues:

**Summary of Campus Forum:** Many thanks to those who attended last Friday's open campus forum, where four focus groups discussed the college mission statement and made suggestions for the revision of an initial draft that will be considered again during the fall 2012 semester. In accordance with accreditation standards, the college mission

atement must (1) define an institution's broad educational purpose, (2) state its intended student population, and (3) declare the faculty and staff's commitment to achieving student learning. In addition, accreditation standards require the mission statement to be central to college planning and decision-making processes. Per the survey results that have already been shared with you, many feel that the current mission statement no longer reflects the programs and services we are prepared to offer and is too wordy. Several variations of a revised mission statement emerged on Friday. Among them:

#### Alternative 1:

Ventura College transforms students' lives, develops human potential, improves communities, and makes Ventura County a better place to live. The College serves a diverse student population by providing essential instruction and student services, with an emphasis on associate degree and certificate completion, preparation for transfer to a four-year college, and basic skills. The College is committed to continuous improvement through the use of promising best practices, emerging technologies, the assessment of learning outcomes, and the modification of programs and services based on this assessment.

#### Alternative 2:

Ventura College transforms students' lives and develops our community's diverse human potential. The College provides essential instruction and student services, with an emphasis on associate degree and certificate completion, preparation for transfer to a four-year college, and basic skills. In addition, the College promotes opportunities for student engagement. The College is committed to continuous improvement and the modification of programs and services based on the assessment of learning and services outcomes.

Alternative 3 (which represents an attempt to boil everything down to one sentence): Ventura College strives to educate, develop, and encourage a diverse student population by providing essential instruction and student services through the use of best practices and student learning outcomes. We will engage a broader cross-section of the campus as we continue to wrestle with the challenge of meeting the required elements while crafting a statement that is long enough to be useful for accreditation and planning purposes and short enough to be memorable!

**Bedback Needed on District Functional Map:** Update #63 notified you that a draft revision to the core content of the District's *Participatory Governance Handbook* had been posted to the portal for your review. That document has been revised once again, and now contains an updated version of the District's functional map (which describes where the responsibilities of the district and the colleges overlap, the relationship of the district to the colleges, and the relationship of the colleges to each other as manifested through the various district councils). Accreditation Follow-Up Report: As discussed at this morning's Flex Day meeting, our college follow-up report to the Accrediting Commission is ready for your review. Please provide your feedback to your respective senates and/or forward any issues of concern directly to my office. The Board of Trustees will see our draft report at its September meeting, so your first round of feedback is due to me no later than Monday, August 27. **Change in First Forum Date and Location:** The date of our first open college forum has been changed to Friday, September 28, and the location has been moved from the Wright Event Center to Guthrie Hall. The time for the forum remains 1:00 - 3:00 p.m. Chancellor Jamillah Moore will be our guest for a portion of this forum. At this meeting we will also be continuing our efforts to revise our mission statement and we will be reviewing our college's institutional effectiveness data.

**Participatory Governance Handbook:** In order to address several district-level accreditation concerns, last spring the District Consultation Council worked for many months on a revision to the district *Participatory Governance Handbook*. This document identifies the charge of district-wide decision-making, advisory, and governance recommending bodies, maps the path of recommendations moving from these groups to the Board of Trustees, and provides for lines of feedback from the groups receiving recommendations. Here is a brief overview of significant changes from the past:

- District Consultation Council: This representative group has added district-wide planning to its charge.
- <u>District Council on Accreditation and Planning (DCAP)</u>: This newly-formed group is an evolving body established to address immediate accreditation and planning issues. As such, DCAP advises the Chancellor, through Cabinet and the District Consultation Council, on matters pertaining to the development, monitoring, and evaluation of district-wide planning and accreditation cycle activities.
- <u>Institutional Research Advisory Committee (IRAC)</u>: IRAC is charged with supporting district and college decisionmaking in the areas of enrollment management, planning, academic program review, performance and outcomes assessment, accreditation, and organizational development. IRAC functions include coordination of research activities, developing, evaluating and regularly distributing basic community demographic information and performance indicators through the district-supported DataMart; and assisting to ensure correct and complete MIS data collection and submission to the California Community College System Office.
- <u>District Council on Academic Affairs (DCAA)</u>: The group District Council on Academic Affairs advises the Chancellor through Cabinet and the District Consultation Council regarding instructional program development and related Board policies, administrative procedures, and standard operating practices; DCAA facilitates the coordination of District college programs and reviews institutional offerings for redundancy, growth and development, and discontinuance; and prepares the initial draft of the educational master plan as it relates to instruction and student services. The District Council on Academic Affairs is advised by two District workgroups on academic and professional matters, the <u>District Technical Review Workgroup</u>, Instruction (DTRW-I) and the <u>District Technical Review Workgroup</u>, Student Services (DTRW-SS). DCAA replaces the former District Council on Student Learning (DCSL) and DTRW-I replaces the former District Technical Review Workgroup (DTRW) that dealt exclusively with curriculum.

Our district is on the agenda to present our famous multicampus model I mentioned at this morning's Flex Day meeting. Attendance is free and each college can register up to five people for the workshop. **Peter Sezzi** (Academic Senate), **Kathy Scott** (Institutional Effectiveness), and **David Keebler** (Business Services) will be three of the five, with the remaining two slots yet to be filled.

**Classified Professional Development:** The college's Professional Development Committee has been expanded to now include activities for classified employees as well as faculty members. In addition, \$5,000 in one-time dollars have been allocated to support speakers, workshops and other professional development activities for classified employees as designated by the Professional Development Committee. For more information about professional development, contact **Gwen Huddleston** or **Sharon Beynon**.

**Business Tools:** Many of you may already be familiar with the district's human resources "toolbox" on the portal, which provides links to procedures and forms related to the employment process. Business operations has now followed suit with its own Business Tools link, which can also be found on the portal. The Chancellor's Consultation Council has been working on District participatory governance documents in response to accreditation recommendations regarding organizational/functional mapping. Consultation Council revised the District's existing Participatory Governance Handbook (i.e., core content and functional mapping) and developed a Governance Process Chart. The Participatory Governance Handbook describes the participatory governance process used within the District and defines the roles and authority of various committees. The Functional Mapping (beginning on page 28 of the Handbook) describes the areas of responsibilities between the district and colleges and where responsibilities overlap. The Governance Process Chart shows the flow of decision-making/recommendations between advisory committees, decision-making bodies, and recommending bodies to the Chancellor and Board of Trustees.
