PETITION TO AUDIT CLASS

AUDIT POLICY

Accordance with Section 72252.3 of the Education Code, students enrolled in 10 units or more may, with instructor consent, be allowed to audit **one lecture only class** per term without a fee. Students enrolled in less than ten units may, with instructor consent, audit one lecture only class per term for a non-refundable fee of fifteen dollars (\$15.00) per unit per semester. As required by section (d), priority in class enrollment shall be given to students desiring to take the course for credit towards a certificate or degree. Therefore, students wishing to audit may register for classes in audit status by special classes petition. This petition requires permission of the instructor. **LABORATORY CLASSES ARE NOT AVAILABLE FOR AUDIT.** In accordance with the section (c) of this statute, no student auditing a course shall be permitted to change his or her enrollment in that course to receive credit for the course.

Students auditing a course are not permitted to take exams in class, nor are they permitted to challenge the course at a later date. Instructors are under no obligation to grade assignments of students auditing a course. Attendance requirements for students auditing courses are the same as for all other students as stated in the college catalogs.

Audit Procedures

- 1. Student may audit one (1) lecture only class per semester or summer session. Laboratory classes are not available for audit
- 2. Enrollment in any audited course may not be changed in an attempt to receive credit for such course.
- 3. Audited courses may not be challenged at a later date in an attempt to receive credit for such course.
- 4. Students auditing a course are not permitted to take exams.
- 5. Instructors are under no obligation to grade assignments of student auditing a course.

Audit Fees

- 1. FALL/SPRING SEMESTERS: No charge if student is officially enrolled in ten (10.0) or more units. Fifteen dollars per unit for students enrolled in 0 9.5 units.
- 2. SUMMER SESSION: No charge if student is officially enrolled in three (3.0) or more units. Fifteen dollars per unit for students enrolled in 0 2.5 units.
- 3. Students who wish to audit a class must pay the student health fee.
- 4. Audit fees are non-refundable
