<b>Course Description:</b>	This 56 hour course is designed to complete to the Firefighter I/II Certification Skills and Written Exams for Firefighter I, Structural, Hazardous Materials and Wildland and Firefighter II, Structural. The components are scheduled over multiple days consisting of the certification skills and written testing. State Fire Training will validate student certifications through the Acadis portal following successful completion of the Firefighter I/II certification exams. State Fire Training (SFT) requirements for Firefighter 1 and Firefighter II including capstone knowledge and skills necessary for Firefighter I & II certification. The requirements for this certification can be found in the SFT Procedures Manual. The Fire Fighter 1 Implementation Plan was developed to provide detailed information regarding how and when the transition to this new certification will go into effect.
