# **DENTAL HYGIENE**

A dental hygienist is a licensed dental professional who is part of the dental care team. They perform services such as oral examination, oral prophylaxis (scaling, root planing, soft tissue curettage and polishing the teeth). They expose and process dental x-rays, administer local anesthesia and nitrous oxide sedation for pain control. Also, they apply preventive medications such as topical fluorides and dental sealants along with instructing patients in oral disease control and nutrition.

Successful Dental Hygiene Program students are eligible to take the National Board Dental Hygiene Examination (written) in their second year. Upon completion of the two-year degree program, graduates qualify to take a clinical exam administered through CRDTS, WREB, or CDCA/ADEX and must take the California Law & Ethics exam (written) to gain licensure.

#### **Career Opportunities**

Dental hygienists usually work in private dental offices or clinics. In addition, there are opportunities for employment in alternative settings such as hospitals, community health programs or public health institutions.

#### About the Program

The Dental Hygiene Program begins each fall and enrolls one cohort of students. This is an intense program requiring a full-time commitment (including evenings and weekend classes and activities). It is highly recommended that the general education courses that are required for the Associate in Science Degree be completed prior to entrance into the dental hygiene program.

All dental hygiene didactic instruction is taught at Oxnard College. Practical clinical experience is gained through a combination of patient experience at our on-site dental hygiene clinic and at off-site rotations. In addition, students will be required to observe at specialty practice offices (i.e., Periodontal, Endodontic, Orthodontic, etc.) or other facilities located off campus. Students will also participate in a variety of enrichment activities such as community health fairs, meetings with dental/dental hygiene societies and associations, conventions of professional dental associations, and community service projects.

#### **Preparation**

High school courses in algebra, biology and chemistry are recommended to prepare the applicant for the prerequisite college classes. Students should plan to complete general education requirements such as fine arts, humanities, and physical education prior to program entry to be eligible for an Associate of Science degree in Dental Hygiene upon completion of the program. # Costs Associated with the Program

Normal student expenses (textbooks, in-state tuition, college fees, etc.) are estimated to be about \$6,000. In addition to the normal student expenses, the dental hygiene program requires approximately another \$11,000 during the two years. These additional costs are associated with instruments, equipment, uniforms, fees for licensing examinations, professional dues, and course expenses. Students who anticipate a financial need should contact the College's Financial Aid Office at (805) 678-5828.

The VCCCD has adopted the state-mandated enrollment fee. The basic enrollment fee is \$46 per unit, and the health fee is \$21 per semester. Other fees, such as nonresident tuition, remain in force. All fees are subject to change without notice.

#### **Applicant Requirements & Selection**

Application packets are available every December for the fall class and are accepted from January 1st to March 1st of the year entrance is desired. Students must have all prerequisites completed by the end of the fall semester of the prior year.\* Applications and additional information is available online under the Dental Hygiene Banner on the OC website.

Applicant Selection is based on the following criteria: As GPA calculations and course equivalencies can vary between institutions, please be sure to confirm your eligibility with an Oxnard College counselor prior to application, (805) 678-5816.

- Completion of all prerequisites by the end of the Fall Semester prior to program entry\*
- 2. Minimum cumulative college GPA of 3.0. (All colleges ever attended must be reported)
- 3.0 or better GPA upon completion of all college science prerequisites; ANAT, CHEM, MICR, PHSO + Labs
- 4. Five-year recency requirement for all science prerequisites
- 5. High School Diploma, GED, or equivalent
- Current BLS CPR AED certification with an inperson skills portion
- \*One science course and DH R001 may be in progress at the time of application

Upon verification of program selection criteria, all qualified candidates will be included in a selection pool. A prioritized lottery selection process is utilized to select the entering students and alternates. There is currently no waiting list; therefore, students not accepted must reapply each year. Candidates taking 32 units of their prerequisites, with 15 units in science prerequisites at Oxnard College, are in the first pool. Candidates who take 32 units of prerequisites, with 15 units in science prerequisites at any of the VCCCD Colleges or SBCC, are included in the second pool along with the first pool candidates. The remaining candidates are in the final pool along with the first and second pool candidates.
