	<p>1. Chris Renbarger and Mike Alexander</p>	<p>Chris Renbarger and Mike Alexander discussed the new Emergency Notification System (ENS).</p> <p>Chris Renbarger: The district has established its own emergency notification system called Revolution. This includes an app, speakers around campus, and others. We tested during the Great Shake Out which provided helpful information.</p> <p>Michael Alexander: Revolution is the name of the program and it's for emergency notifications. In the past we had pull tags and even before that had a speaker system. Both had problems. A few years ago, a work group formed and from the group came the implementing of speakers in classrooms, [announcements] on computers in classrooms, and a clock that's emergency notification with a message display. It is behind the teacher so everyone in the class can see the message. Training materials have been emailed out before the Great Shakeout. It's a quick PPT. We need to test this system regularly and the first was the Great Shakeout. We are engaging the vendor to resolve issues [from that test]. One concern is making sure speakers are working everywhere including parking lots. The noon Westminster Chimes are part of this testing. Much of this started right before we left campus for the pandemic.</p> <p>Discussion:</p> <p>Senator Mike Ketaily: Check out the link for the PPT, if an emergency happens, this will be the most important training you do. Thank for you this Mike, it was badly needed.</p> <p>Senator Emily Zwaal: Are there flashing lights that draw the attention to the notification?</p> <p>Mike Alexander: Yes, there are different messages and different flashing lights per the type of emergency.</p> <p>Chris Renbarger: If can also flash a message on the computer screen.</p> <p>Mike Alexander: It's in all classrooms and different places around campus.</p> <p>Senate VP Elissa Caruth: Will it take over the document camera?</p>	

		<p>Mike Alexander: No. The district made some changes to the portal so that does not happen. Also, please make sure your emergency contact phone number is up to date.</p> <p>Chat: Senator Mike Ketaily: Thank you Mike and Chris for doing this! Senator Deanna McFadden: Does this ENS have flashing lights when an alert goes out? Senator Amy F Edwards: Senators, we will open this up for questions in a moment. feel free to raise a hand Senator Thomas A Stough: "Intrado Revolution DNC"? Is that the desktop app? Senator Amy F Edwards: The app square is Blue and Green with a big R in the middle Senator Amy F Edwards: I just checked Tom. Yes Intrado Senator Lilia Ruvalcaba: I hear it in my classroom Senator Elissa Caruth: The chimes are loud and clear in the classroom! Senator Ishita Edwards: I hear the chimes in my classroom at noon. I didn't know what that was the first time it happened. Senator Shannon Newby: They play in the South Office Wing as well. Senator Lilia Ruvalcaba: me too Senator Ishita Edwards: I am in the LS building.</p>	
	2. Mike Ketaily	<p>Chair of the Covid Task Force, Captain Mike Ketaily, provided details on the progress of the task force. Senator and Chair of CTF: Mike Ketaily: Covid Leadership continues to meet, and the Covid Transition Taskforce continues to meet. Spring 2022 we'll have the same screening stations, with increased staff, we'll review peak times and have minimum of 2 screeners each shift at each location with the iPad and the same wristbands. We'll replace "Easy-Up" station with clear plastic liners. Cleaning will occur once a day (not after every class) and screeners will have walkie talkies to communicate. The group will continue to meet next semester and it may turn into a regular meeting for emergency planning.</p> <p>Discussion: Senate Treasurer Ishita Edwards: What are the plans for regular classroom cleaning for Spring?</p>	

Senator Mike Ketaily: The schedule will be implemented and it will occur once a day. Please treat the staff with respect about this issue, some disrespect is coming from faculty to screeners or staff members.

Senator Della Newlow: Thank you again for leading the Covid Taskforce. With that, I had a question about boosters and vaccine completion. There's a lot of talk in other places around the world that after 6 months you're no longer fully vaccinated compliant and I was wondering if there's any talk about that about requiring boosters at the district levels. If there's been any conversation around that.

Senator Deanna McFadden: When the policy was debated at the BoT, two Board members were not at all comfortable adding boosters to policy and I have heard no further discussion about implementing boosters to the policy.

Senator Della Newlow: Just a follow-up then, knowing they are not nearly as good after 6 months I would just put out the request that I vote to keep obviously masking in place until maybe that's brought up again.

Senator Deanna McFadden: There is no talk of removing the mask mandate. We implemented that before the country did. We will keep it for the Spring.

Senator Michael Sheets: In regard to that, I was at the table for MOU negotiations. This was not addressed because the BoT were divided about boosters as part of mandate. The discussions contemplated the idea of booster as part of "full-vaccination". We were careful that any provisions that apply to the original vaccines would apply to boosters. The BoT wasn't clear and we weren't ready to tackle that for the reasons you expressed. The District is not interested in getting rid of mask mandate anytime soon. Part of the MOU gave the District the ability to keep the mask mandate even after the county does not.

Senator Della Newlow: There just isn't enough recognition for people at work who do amazing things. With that, is that an appropriate use of AS funds? I don't think it is. I would say that we do need to recognize people and one idea I thought about was I was looking at the college website and maybe put the person recognized for the month, put them on the cover of our web page. There are ways to do things without the monetary gifts or cash. If we don't do the gifts and flowers it's going to turn back to everybody's own pockets again of who's going to bake a cake or make cookies. That's my concern by not doing it. I'm feeling conflicted, but I'm not a fan. AS funds should be going to AS agenda.

Senator Rainer Mack: I agree with Della, although I'm not conflicted. We don't need to attach money to it, I'd rather to get a plaque or be put on the website instead of \$200.

Senator Lois Zsarnay: We had this conversation before and I agree with Della. I'm concerned that it's not the appropriate use of the dues that people pay. What do they expect? We don't have the funds to give everybody money. Money goes away, but something to display, like the plaques we had for public recognition. Maybe public recognition is better. We answer to the people who pay dues.

Senator Dolores Ortiz: The plaques cost money. If we were at a University, there would be funds if someone experienced a death in their family. This is the only humanizing body that can extend that hand, but I also understand we should review our purpose.

Senate Treasurer Ishita Edwards: The issue was whether they should be cash gifts or non-cash gifts. There's some unhappiness with cash gifts as recognition. I never heard of any issues of people getting flowers.

Senator Della Newlow: It was anything that costs money. It was the idea of using AS funds for things that cost money for a gift for someone whether it's flowers it's money, it's a bottle of wine. It's the idea that AS funds should be used to move forward the AS agenda and whether or not we are doing that with our funds. And it's fine if everybody thinks we shouldn't be or we should be or that is moving forward in its other way.

Senator Lois Zsarnay: I agree, it's spending money on an item or something like a certificate instead of a plaque.

Senate President Amy Edwards: Let me summarize, it sounds like we don't want to reduce the recognition. I propose we allow ourselves 2 recognition gifts as needed, but we allow them to be on the books. We take cash off the table. I don't feel comfortable removing the Sunshine gifts completely. When somebody has a loss, we

want to send something. We don't want AS to not pay attention to some of those sunshine elements. We also haven't sent to a lot of people who needed sunshine, so we pick and choose those big ones. So, I propose the ones that were brought to the Senate by senators were funded. We need to allow ourselves the ability to do it. Removing all sunshine to me means we are going to disconnect ourselves from anybody not in this room. Take cash off the table, we allow ourselves the ability to recognize, and if a senator comes forward we vote.

Senate Treasurer Ishita Edwards: If we agree to go that route, should we agree to have 2 recognitions, and limit how much we are going to spend per gift. Have a cap.

Senator Tim Fontenette: I like the idea of limiting it to 2 outstanding gifts. This one was a very unique situation and unbelievable time that she handled masterfully, and Laura's gift was very unique time. We need to make sure there are caps and limits. There can be different levels, and they can be recognized differently, like cards.

Senator Lilia Ruvalcaba: We have an asset on our campus: student art work and sometimes it goes up for sale. We should be purchasing this for recognition for faculty. It'll be a nice piece of artwork hanging in the classroom and constant reminder of appreciation for their service.

Senator Della Newlow: I can back peddle here weather it is AS's goal or not. Some community colleges have a whole list of awards they give out. I like the idea of solidifying that. It feels abstract. We have something that is a grievance, there is a budget for that, and one for a super star award for whatever reason.

Senate President Amy Edwards: That is the goal and to remind everybody the plaques are from the Big 6 Employee Excellence Awards. They will be updated and paid for by President's office.

Senator Rainer: Whatever the result let's include some basic principles to guide this in the future.

Senate Treasurer Ishita Edwards: Just to add to what Tim said select a couple and cap it, and make a card.

Senator Shannon Newby: As a recipient as a gift from the AS when I was in the hospital with a traumatic brain injury which I am still recovering from. It was really beneficial to my in my healing to have the acknowledgement that me peers were thinking of me. And a card would have been fine, but I don't think we should underestimate the value in acknowledging the contribution of our peers and how much it means to receive something. It is so valuable to have that acknowledgement from my colleagues. That is part of supporting faculty.

Senate President Amy Edwards: This is an ongoing discussion. I don't anyone is too far away from each other. I just don't want us removing the possibility of recognition. We need to put guard rails in the bylaws or leave it to the executive committee to make those decisions. We have a bylaws workgroup who should be the next place to work this out. We can put it in the workgroup's hands and then we look at our bylaws in its entirety. Next meeting we'll get an update from that group.
