Acceptance of this Agreement constitutes that the CONTRACTOR is not covered under the DISTRICT'S general liability insurance, employee benefits or workers' compensation. It further establishes that the CONTRACTOR shall be fully responsible for such coverage.

<u>Termination</u>: This agreement may be terminated by either party upon a thirty (30) day written notice to the other party in the event of failure of performance.
