
Sexual Misconduct / Title IX Information

Office of Title IX (Sexual Misconduct)

How does it affect you as a Student of Oxnard College?

Members of the Oxnard College community, guests, and visitors have the right to be free from sexual misconduct and any other form of sexual harassment and gender-based discrimination and violence.

OC DOES NOT TOLERATE sexual misconduct, which includes, but not limited to:

- Sexual harassment (in person, by text, or online)
- Domestic violence
- Dating violence
- Sexual assault
- Sexual stalking
- Gender based Hate Crimes

When an allegation of misconduct is brought to an appropriate employee's attention and a Respondent is found to have violated any sexual misconduct policies, appropriate sanctions will be used to reasonably ensure that such actions are never repeated.

The following information explains campus community expectations and seeks to establish a mechanism for determining when those expectations have been violated. Likewise, the information gives reporting options and on/off-campus resources to support students who have been victims of sexual misconduct.

All OC community members have the duty to understand student rights and responsibilities; therefore, it is important that you are familiar with the following policies and procedures as it relates to gender equity and gender-based discrimination, harassment, and violence:

In 2016, California passed a law ([Senate Bill 967 \(http://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill_id=201320140SB967_\)](http://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill_id=201320140SB967_)), known as the *Yes Means Yes* law, requiring both parties who are engaging in sexual activity to give an on-going consent .
