The League agrees to act as fiscal agent for participating community colleges. Oxnard Community College shall coordinate and obtain commitments from their college to insure that each library understands and acknowledges responsibility for compliance and conformance with individual license terms and conditions. Such license terms and conditions shall be made available to the Libraries via the consortium web site (www.cclibraries.org). College understands that the consortium pricing is confidential between the consortium and the library.

For each Subscription Order, the League shall collect the amount due from Oxnard Community College and submit payment to the vendor. The Oxnard Community College is responsible for the prompt and complete payment for all invoices when received. Procedures for delinquent invoices include a 5% penalty fee and suspension of access to the database(s) when payment is 90 days past the date of issuance on the invoice.

Either party has the right to cancel this Agreement at any time. Cancellation shall not entitle Oxnard College to any refund of fees paid in advance on their behalf.

Any dispute arising under the terms of this Agreement which is not resolved within a reasonable period of time by authorized representatives of the Community College League and Oxnard Community College shall be brought to the attention of the Chief Executive Officer (or designated representative) of the League and the District Chancellor (or designee) of the Oxnard Community College for joint resolution.

This Agreement shall be construed in accordance with and its performance governed by the laws of the State of California.
