## DISTRICT-WIDE DIVISION OF ECONOMIC & WORKFORCE DEVELOPMENT – STATE OF CALIFORNIA EMPLOYMENT TRAINING PANEL

#### Background

Established in 1982, the Employment Training Panel (ETP) has remained California's premier program for supporting job creation and retention, through training. ETP is funded by a special tax on California employers and differs from other workforce development organizations whose emphasis is on pre-employment training. ETP fulfills its mission by reimbursing the cost of employer-driven training for incumbent workers and funding the type of training needed by unemployed workers to re-enter the workforce. ETP's program helps to ensure that California businesses will have the skilled workers they need to remain competitive.

Employers must be able to effectively train workers in response to changing business and industry needs. While the need for workforce training is critical, businesses generally reserve capacity building dollars for highly technical and professional occupations – limiting investment in training for frontline workers who produce goods and deliver services. ETP helps to fill this gap by funding training that is targeted to the frontline workers.

#### <u>Analysis</u>

#### District-Wide Division of Economic & Workforce Development

This ETP funding serves the mission of the District-wide Division of Economic & Workforce Development by actively supporting workforce and economic development in Ventura County through partnerships and relevant programs and pathways leading from education to careers.

Funding from this contract will be used to train previously ineligible businesses such as non-profits and government agencies and will enhance the ability for the District-Wide division of Economic & Workforce Development to deliver short-term training to local employers. In order to utilize ETP funds, both the employer and the training need to meet eligibility criteria. Budget under "Other Operating Expenses" includes billing services.

The total amount is \$41,595. The term of the contract is from December 20, 2021 to December 19, 2023.
