General Information

A dental hygienist is a licensed dental professional who is part of the dental care team. They perform services such as oral examination, oral prophylaxis (scaling, root planning, soft tissue curettage and polishing the teeth). They expose and process dental x-rays, administer local anesthesia and nitrous oxide sedation for pain control. They also apply preventive medications such as topical fluorides and dental sealants along with instructing patients in oral disease control and nutrition.

Successful Dental Hygiene Program students are eligible to take the National Board Dental Hygiene Examination (written) in their second year. Upon completion of the two-year degree program, graduates qualify to take a regional clinical exam, and must take the California Law & Ethics exam (written) to gain licensure.

The Dental Hygiene facility is located on the Oxnard College main campus, 4000 South Rose Avenue, Oxnard, CA 93033, on the corner of South Rose Avenue and South Campus Road. Career Opportunities

Dental hygienists usually work in private dental offices or clinics. In addition, there are opportunities for employment in alternative settings such as hospitals, community health programs, public health institutions, and education.

Transfer Opportunities

Students who complete the Associate Degree in Dental Hygiene may wish to transfer and continue their education in pursuit of a Bachelor's Degree. While there are currently no articulated transfer guarantee pathways within Dental Hygiene, numerous opportunities exist for students to pursue continued education. The transfer process is unique to a students' plan and pathway; thus, it is important to see a counselor and the University Transfer Center to create a plan and for help with transfer applications. About the Program

The Dental Hygiene Program admits 20 students every Fall semester. After the initial 20 are drawn, the remaining applicants are placed on an alternate list to fill any available spaces should an admitted student decline a place in the program. Students not selected must reapply each year. This is an intense program requiring a full-time commitment (including evening and weekend classes and activities). IT IS HIGHLY RECOMMENDED THAT ALL OF THE GENERAL EDUCATION COURSES REQUIRED FOR THE ASSOCIATE IN SCIENCE DEGREE BE COMPLETED PRIOR TO ACCEPTANCE INTO THE HYGIENE PROGRAM.

All dental hygiene didactic instruction is taught at Oxnard College. Practical clinical experience is gained through a combination of patient experience at our on-site dental hygiene clinic and at off-site rotations. In addition, students will be required to observe at specialty practice offices (i.e., Periodontal, Endodontic, Orthodontic, etc.) or other facilities located off-campus. Students will also participate in a variety of enrichment activities such as community health fairs, meetings with dental/dental hygiene societies and associations, conventions of professional dental associations, and community service projects.

Preparation & Prerequisites

High school courses in algebra, biology and chemistry are recommended to prepare the applicant for the prerequisite college classes. Students should plan to complete general education requirements such as health, fine arts, humanities, and physical education, history or political science, communication/analytical thinking, and math prior to program entry to be eligible for an Associate of Science degree in Dental Hygiene upon completion of the program.

Advanced Placement (AP) Exam Score Exemption may be accepted in lieu of OC College Program English Composition and Math prerequisites.

ALL SCIENCE PREREQUISITIES MUST HAVE LABS. Prerequisite biomedical science courses can either be completed by traditional, in-person wet labs at the school or online using a physical lab kit that allows the student to conduct physical experiments in conjunction with an online synchronous meeting system with faculty oversight and teaching. This applies to the subjects of anatomy, physiology, chemistry, biochemistry, and microbiology.

APPLICATION & SELECTION: Applications are available online at oxnardcollege.edu/departments/academic/dental-hygiene or by sending a self-addressed, pre-stamped envelope to the Dental Hygiene office (a regular sized envelope is adequate) and the application period is from January 1st – March 15th of the spring semester prior to fall entry.

QUALIFIED APPLICANTS MUST HAVE:

1. Completed all OC Dental Hygiene program prerequisites by the end of the Fall Semester prior to program entry *
2. Minimum cumulative college GPA of 3.0 (All colleges ever attended must be reported)
3. Minimum prerequisite science GPA of 3.0 upon completion of all college science prerequisites (includes ANAT, CHEM, MICR, PHSO + LABS)**
4. Completed all science prerequisites within a five-year period prior to application
5. High School Diploma, GED, or equivalent
6. Current CPR card (Basic Life Support CPR & AED Training for Healthcare Professionals) with in person skills portion

***One Science prerequisite course may be in progress at the time of application in the spring (lecture and corresponding lab will be considered one science prerequisite).**

***As GPA calculations and course equivalencies can vary between institutions, please be sure to confirm your eligibility with an Oxnard College counselor prior to application*

Upon verification of program selection criteria, all qualified candidates will be included in a selection pool. A prioritized lottery selection process is utilized to select entering students and alternates. Candidates who take 32 units of prerequisites, with 14 units in science prerequisites at Oxnard College, are in the first pool. Candidates who take 32 units of prerequisites, with 14 units in science prerequisites at any of the VCCCD colleges or SBCC, are included in the second pool along with the first pool candidates. The remaining candidates are in the final pool along with the 1st and 2nd pool candidates. Only 20 students are admitted each year. All names drawn after the initial 20 are placed on an alternate list. The alternate list is used to fill any available spaces in the program should any applicants decline a place in the program. However, there is no wait list. Students not selected must reapply each year.

ASSOCIATED COSTS

Normal student expenses (textbooks, in-state tuition, college fees, etc.) for the program are estimated to be about \$6,000. In addition to the normal student expenses, the dental hygiene program requires approximately \$11,000 during the two years. These additional costs are associated with instruments, equipment, uniforms, supplies, licensure examination fees, professional dues and course expenses.
