- J. Leiser shared concerns from his department regarding when the OTTCC training will be implemented and inquired if faculty will be required to retake the 40 hour course when they are teaching. He asked if it could be shortened to a recertification course. E. Caruth will bring these questions and concerns to Laura Knight. L. Gonzalez said the district is working on redesigning a course for recertification.

6. Old Business

6.01 PGM

• E. Caruth reported that the meeting with ASCCC and CCLC regarding the PG Manual was a success and posted her recommendations and the documents for use going forward into Fall 2024. She thanked the senators who brought the issue forward. David Morse will be visiting OC on Friday from 3-5pm.

- D. Newlow asked what decisions came from the meeting and whether it was determined if our manual is legal and in compliance. E. Caruth responded that we are not violating the law and will not lose our accreditation but there is work that can be done to strengthen our manual. She encouraged everyone to look at the document "Oxnard PGM" and read David Morse's comments. There is debate as to whether the language should state that we are a "primarily rely upon" body or "mutually agree upon" recommending body (as it's currently written in our board policy). She noted that we were applauded for including the 9+1 for classified but that overall it was a positive meeting and senators can use what was learned to review the manual going forward.
- J. Redding asked E. Caruth to share David Morse's comments from the last page. She pointed out that we were told we are out of compliance with Title 5. E. Caruth responded that we should wait to address this in Fall 2023.
- D. Ortiz pointed out that there was no decision made, it was more of a general training and it's up to us to come to agreements on any changes. There will also be more pointed feedback given at Friday's upcoming meeting.
- D. Newlow pushed for a greater discussion on the matter because she did not feel clear on what came of that meeting, which we had been waiting on the outcome of the whole semester. The language from David Morse's comments were then read aloud, which claimed that we are in fact out of compliance.
- C. Renbarger shared that he was happy to read the feedback given to us concerning the makeup of the College Planning Council (CPC) and the blocking language. Specifically, if the CPC votes down something that Academic Senate is in favor of, Academic Senate has the right to then take this to the President and express their disapproval.
- E. Zwaal added that we were strongly advised to work collaboratively with our colleagues across campus from the other constituency groups. It is paramount that we work through any changes together and invite everyone to the table.
