|      | a) CERT Training               | Ι     | M. Ketaily introduced Susan Duenas from the City of<br>Oxnard for CERT (Community Emergency Response<br>Training). Susan passed around a document of<br>Oxnard CERT which provides Sessions 1-7 of the<br>training they provide. Each session is 3 hours but<br>can be broken out however works best for the<br>organization. No cost, all free and they bring<br>supplies. They like to have a minimum of at least 20<br>attendees but have done as many as 35 but it gets<br>challenging. There is a high demand for the class. |

The class can be done on campus, but would be nice to do it at the Fire Station, possibly the new Station 9. The next step is to get commitment from everyone. Friday's seem to work better. WE will take a look at it and get people signed up, hopefully early February.

L M. Bush talked about air conditioning issues, which is not part of the Master Plan for the college. The plan Plan – Air was to create new classes and expand space. That's Conditioning what the bond is for. Specifically science laboratory space and a permanent spot for our visual arts program. Those were the goals of the facilities master plan besides classrooms. He believes we need to take a thoughtful review of air conditioning and make a determination whether or not we want to recommend to PBC to amend the master plan. He added that Mel Soto and Bob Sube can do a survey of all our instructional space and map out the whole campus as to what has air conditioning and what does not. We can then bring in an expert consultant to look at the campus and provide what should/can be done and give us a recommendation with the cost parameters. Right now we use the square foot unit which would be about \$500 million to do everything. Once we have the facts in order we can make a recommendation to PBC on how the master plan should be updated.

> E. Rivera made a motion to have a consultant come in and look at the campus, D. McFadden seconded, and the motion was accepted unanimously.

c) El Nino Preparation L M. Bush talked about the levee and issues when El Nino hits. Susan Duenas with the City of Oxnard said it's still vulnerable, so they are watching it. City of Oxnard will be in constant contact with Watershed Protection District. If there is an evacuation – it will notify VC Alerts. Susan said we don't have an FYI mechanism. Mike said if she has an incident commander to send them to him so we can work together to get info/alerts out.

> As far as the levee goes – Susan said El Nino just means that we are going to have a lot of storms. This becomes problematic when the ground gets really saturated. A couple weeks of consistent rain can change everything. That's when they start monitoring things on a regular basis. Hoping that the storms are spaced out enough.

b) Facilities Master

Mike said first thing – we want to get the water off the grounds and over to our duck pond. Our director has started looking into surface drains and because of the drought they have filled up with tree roots. We've had them all cut out and are opened up and can move water off campus. We are repairing rain gutters. Continuing to test the roofs – because they have dried out and are hard and cracked. We have a couple repairs to do and are working on them now. Other issue with drought is the toll it took on our trees. Last winter – we were dropping major limbs off eucalyptus. All our trees were inspected and too high risk – we had to take them out. Roots were just too damaged. Next, looking at mechanical systems which appear to be fine. Looking to see how we can support the community with shelters. He added as we get going in El Nino we will look at our communications and talk about what we can do to notify everyone regarding traffic.
